Dear Mr. Noah:

In a letter dated February 28, 2008, you were advised of the termination of your individual RRSC membership. (We have confirmation that you received the letter via e-mail from you dated March 7, 2008.) Among other things, the termination letter stated that you were prohibited from “coach[ing] any RRSC team.” Despite the knowledge that you are prohibited from coaching any RRSC team, you served as the coach for the RRSC P24 co-ed team at the 5:45 p.m. game on Thursday, March 13, 2008. Your conduct shows that you ignored the prohibition set forth in the membership termination letter. Unfortunately, the RRSC Board of Directors is forced to take further action to prevent you from disregarding RRSC directives or otherwise interfering with RRSC activities.

Enclosed is a Trespass Notice which prevents you from entering any facility or property rented by the Red River Soccer Club from the Fargo Park District. The Trespass Notice begins on today's date and expires on March 2, 2009. You are hereby given notice that any permission or license you may have previously enjoyed to enter upon any facility or property rented by the Red River Soccer Club from the Fargo Park District (i.e., Pepsi Soccer Complex, Brunsdale Park, Metro Rec Center, etc.) is hereby revoked and withdrawn. This trespass notice covers the entire property occupied by the Red River Soccer Club including, but not limited to, the parking lots, entrances, and adjacent property. In accordance with North Dakota Century Code § 12.1-22-03(3), you may not enter upon such property for any purpose without the express written permission of an authorized representative of the Red River Soccer Club. This trespass notice shall expire on March 2, 2009.

Please note that an authorized representative of the Red River Soccer Club may modify, amend, or rescind this trespass notice. However, any such modification, amendment, or rescission must be in writing in order to be effective.
